The Importation of Animals Order 1977 (Article 3 (2))

Paragraph 3 of the health certification requirements, which appeared on page 1802 of the *London Gazette* dated 9th February 1982, should be deleted, and the following inserted:

3. Within 21 days prior to the intended date of export, sheep to be exported were totally immersed in an approved dip containing an active principle effective against ectoparasites including *Psoroptes communis* var *ovis* and *Sarcoptes scabiei* var *ovis*, to the satisfaction of the duly authorised veterinary officer.
