SOUTH BEDFORDSHIRE DISTRICT COUNCIL

The South Bedfordshire District (Steppingstone Bridge, South Street, Leighton Buzzard) (7.5 Tonnes Gross Vehicle Weight Restriction) Order 1982.

Notice is hereby given that the South Bedfordshire District Council pursuant to arrangements made under section 101 of the Local Government Act 1972 with the Bedfordshire County Council under section 1 (1), (2), (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended, and after consultation with the Chief Officer of Police in accordance with section 84C (1) of the said Act of 1967, propose to make this Order, the effect of which will be:

To prohibit any person from causing or permitting any motor vehicle which has a maximum gross vehicle weight in excess 7.5 tonnes to proceed in that length of South Street in the Parish of Leighton-Linslade over the Steppingstone Bridge crossing the Clipstone Brook for a distance of 15 feet in a north-westerly direction and 15 feet in a south-easterly direction.
