LACE FINISHING WAGES COUNCIL (GREAT BRITAIN)

The Lace Finishing Wages Council (Great Britain) hereby gives notice of proposals for (1) amending the provisions relating to statutory minimum remuneration as set out in the Wages (Lace Finishing) Order 1981 (Order L(56)), (2) amending the provisions relating to holidays and holiday pay as set out in the Wages (Lace Finishing) (Holidays) Order 1980 (Order L(54)), as amended by Order L(56); and (3) the revocation of Order L(56).

The Wages Council intends that the revised provisions shall come into operation on 2nd August 1982.

Particulars of the proposals are contained in the Wages Council's notice L(57), copies of which may be obtained on application to the Secretary of the Wages Council at the address given below. The Wages Council will consider any written representation concerning these proposals if received within 14 days from 1st June 1982. It is desirable that persons making objections should state the precise nature of their objections and quote the number of the Wages Council's notice of proposals L(57).

The New Town of Redditch Extinguishment of Public Rights of Way Part of Footpath No. 73, Redditch
