The Cardiff—Llangurig Trunk Road (Abercynon—Pentrebach Diversion Side Roads) Order 1979 (Variation) (No. 2) Order 198

The Secretary of State for Wales hereby gives notice that he proposes, in relation to the above-mentioned Trunk Road between Abercynon and Pentrebach in the County of Mid Glamorgan, to make under sections 14, 125 and 326 of the Highways Act 1980, an Order which will:

(ii) the realignment of the proposed private means of access to National Coal Board property at Aberfan.
