The Raglan-Llandovery Trunk Road (Skew Bridge, Abergavenny to Raglan Village Diversion Side Roads) (Variation) Order 198

The Secretary of State for Wales hereby gives notice that The Secretary of State for Wales hereby gives notice that he proposes, in relation to the above-mentioned Trunk Road between Skew Bridge, Abergavenny and Raglan Village in the county of Gwent to make an Order under sections 14, 125 and 326 of the Highways Act 1980, which will vary the Raglan—Llandovery Trunk Road (Skew Bridge, Abergavenny to Raglan Village Diversion Side Roads) Order 1976, by deleting provision for the two private means of access across fields to the east of Huntsman's Lane (Route C26-27) near Clytha Park.

R11/230/20 and stating the grounds of objection.
