PASTORAL MEASURE 1968

Notice is hereby given that Her Majesty was pleased on 23rd June 1982, by Order in Council to confirm the following Schemes made by the Church Commissioners for:

- Uniting the benefices of Liskeard with St. Keyne and St. Pinnock; and Morval, in the diocese of Truro, and establishing a team ministry for the area of the new benefice.
- Uniting the benefices and parishes of Kidderminster and St. Oswald-in-Usmere, Broadwaters;
 - (2) establishing a team ministry for the area of the new benefice;

- (3) amending an earlier Scheme establishing a group ministry to include the new benefice; and
- (4) establishing a team ministry for the area of the benefice of St. George, Kidderminster, in the diocese of Worcester.
- Declaring redundant the church of St. John the Divine, Wildsworth, in the diocese of Lincoln.
- Uniting the benefices of Hardrow and Lunds; and Hawes; and uniting the parishes of Hardrow and Lunds, in the diocese of Rippon.
- 5. Transforming the parish of West Bradley from the benefice of West Pennard with West Bradley to the benefice of Baltonborough with Butleigh and altering the names of the said benefices, in the diocese of Bath and Wells.
- Uniting the benefices of Poynings; Edburton; and Newtimber with Pyecombe, in the diocese of Chichester.
- Uniting the benefices of Christ Church, Chalford; and St. John the Baptist, France Lynch, in the diocese of Gloucester.
- 8. Uniting the parishes of East Bradenham and West Bradenham and transferring a share of the patronage of the benefice of Shipdham with East and West Bradenham, in the diocese of Norwich.
- 9. Uniting the benefices of Fleet and Gedney, in the diocese of Lincoln.
- Uniting the benefices of St. Luke, Holbeach Hurn; and St. Mark, Holbeach Marsh, in the diocese of Lincoln.
- 11. Uniting the benefices of Harthill and Thorpe Salvin, in the diocese of Sheffield.
- 12. Declaring redundant the church of St. Mary the Virgin, Sydmonton, in the diocese of Winchester and appropriating it and the annexed land for disposal for use as a monument and for artistic purposes.
- 13. Creating the new parish of Birchover, and uniting the benefices of Youlgreave and The Holy Trinity, Stanton-in-Peak, in the diocese of Derby.
- 14. Uniting the benefices and parishes of Alton and Bradley-le-Moors, in the diocese of Lichfield.
