The District Council of Selby (Public Right of Way No. 10 Selby) Public Path Diversion Order No. 1, 1982

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 25th June 1982, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the District Council of Selby as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the footpath running from a point on Cockret Lane adjacent to the Northern side of No. 83 Charles Street, Selby, and proceeding in a north-westerly direction along Cockret Lane for 134 metres to a point 12 metres south-east of Cockret Farm, Selby, to a line running from a point on Cockret Lane adjacent to the northern side of No. 83 Charles Street, Selby and proceeding in a westerly direction for 141 metres and then a northerly direction for 52 metres to a point 12 metres south-east of Cockret Farm, Selby.

Vale of White Horse District Council (Footpaths Nos. 19 and 25 Cumnor) Public Path Diversion Order 1982

Notice is hereby given that the above-named Order made on 29th June 1982, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Vale of White Horse District Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public rights of way, in respect of Footpath No. 19, running from a point 134 metres south-west of its junction with Nobles Close, Botley, in a south-westerly direction for a distance of 260 metres to a new line commencing at the same point and running in a south-south-westerly direction for a distance of 35 metres, then south-east for a distance of 8 metres, then south-west for a distance of 165 metres, then north-north-west for a distance of 20 metres to rejoin the existing path for a distance of 10 metres to the south-west, then north-north-west for a distance of 22 metres, then 35 metres south-west, then 25 metres south to rejoin the existing path.

In respect of Footpath No. 25, the effect of the Order will be to divert the public right of way running from its junction with Footpath No. 19 in a north-north-westerly

direction for a distance of 40 metres to a new line commencing at the same point and running in a northerly direction for a distance of 25 metres and then north-west for a distance of 8 metres to rejoin the existing path at the point where it crosses the Cumnor By-pass.
