THE HIGHWAYS ACT 1980

The London-Holyhead Trunk Road (Improvement at Turnpike Nant Junction, Llangefni, Side Roads) Order 1982 The Secretary of State for Wales hereby gives notice that, in relation to the above-named Trunk Road at Turnpike Nant, Llangefni in the County of Gwynedd, he has made under section 14 of the Highways Act 1980 an Order, the effect of which is:

- (a) to authorise him:
 - (i) to improve, raise, lower or otherwise alter the roads to Llangefni and Llangristiolus,
 - (ii) to stop up the road to Llangristiolus,
 - (iii) to construct a new highway to connect the road to Llangristiolus (as improved) with the Trunk Road, all at Turnpike Nant, Llangefni aforesaid; and
- (b) to provide for the transfer of the said new highway to the County Council of Gwynedd as from the date on which he notifies the Council that the new highway has been completed and is open for through traffic.

Copies of the Order and of the relevant plan have been deposited at the Welsh Office, Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, and at the offices of Gwynedd County Council, Highways and Transportation Department, Maesincla, Caernarfon; Gwynedd County Council, Area Office, Highways and Transportation Department, Shire Hall, Llangefni, and Ynys Mon Borough Council, Shire Hall, Llangefni, where they are open to inspection free of charge at all reasonable hours.

Copies of the Order, the title of which is "The London-Holyhead Trunk Road (Improvement at Turnpike Nant Junction, Llangefni, Side Roads) Order 1982", can be obtained from the Welsh Office, Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980, or on the ground that any requirement of that Act, or of regulations made thereunder, has not been complied with in relation to the

Order, may, within 6 weeks from 22nd July 1982, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
