## ROAD TRAFFIC ACTS

### BRIGHTON BOROUGH COUNCIL

#### *The Brighton Council Road Traffic Orders*

Notice is hereby given that the Brighton Borough Council acting as agents for East Sussex County Council, propose to make Orders under sections 1, 9, 35, 36, 37 and 84D (1) of the Road Traffic Regulation Act 1967, as amended.

The Orders and their effects are as follows:

1. *The Brighton (Baker Street Area) (Experimental Pedestrianisation and One-Way Traffic) Order 1982.*

The following restrictions will be for an initial period of 6 months:

(a) *Baker Street*

(i) vehicles will be prohibited between the junction with Ditchling Road and a point 88 feet east of Kingsbury Road;

(ii) 11 meter bays and a motor cycle bay will be removed;

(iii) waiting will be prohibited between the junction with London Road and a point 88 feet east of Kingsbury Road;

(iv) two-way traffic will be introduced just east of Kingsbury Road.

(b) *Kingsbury Street.* Vehicles will be prohibited between the junction with Ditchling Road and a point 10 feet west of that junction and two-way traffic will be introduced over the remainder of Kingsbury Street.

(c) *Kingsbury Road.* Existing one-way traffic will be reversed (i.e. traffic flow will be from south to north).

(d) *Rose Hill Terrace* (between Kingsbury Road and London Terrace). Traffic flow will be one-way from east to west.

2. *The Brighton (Old Town) (Experimental Pedestrianisation) Order 1982.*

The following restrictions will be for an initial period of 12 months:

*Brighton Place, Market Street* (between northern kerb-line of Bartholomews and western kerb-line of East Street) and *Nile Street.*

All vehicles will be prohibited from the above streets on Saturdays, between 10 a.m. and 4 p.m. except those for which a permit has been issued by the Council and requiring access (a) for loading/unloading and (b) to off-street garages.

All on-street parking places within the prohibited roads will be suspended during the restricted period.

Exempted vehicles will be admitted via Nile Street by use of a permit, obtainable on application to the council, which will operate an automatic barrier at the west end of Nile Street.

3. *The Brighton (Meter Zone Parking Places Consolidation Order 1981) (Amendment No. 6) Order 1982.*

*The Brighton (Meter Zone Restriction of Waiting and Loading Consolidation Order 1981) (Amendment No. 4) Order 1982.*

Additional metered parking spaces will be provided as follows:

(i) East side of Bartholomews, 2 spaces.

(ii) East and west sides of Pavilion Buildings, 4 spaces.

(iii) East side of West Street (between Russell Road and South Street), 6 spaces.

Full details of the proposals are in the draft Orders which, together with maps showing the roads affected and a statement of the council's reasons for proposing to make the Orders, may be examined at the Enquiry Office, Town Hall, Brighton, between 9 a.m. and 4 p.m. on Mondays to Fridays.
