

or ride any cycle in Foss Street, Dartmouth, between the hours of 10 a.m. and 4 p.m. daily from 1st May to 30th September (both dates inclusive).

Exemptions in the Order permit the driving of vehicles in that length of road in connection with building operations, road repairs, supply of gas, water and electricity, for emergency purposes or the service of a local authority or statutory undertaker in pursuance of statutory powers or duties, or with the written permission of the chief officer of police.

DURHAM COUNTY COUNCIL

The County of Durham (Road A694 and Unclassified Roads at Hamsterley) (Prohibition of Waiting) Order 1982.

(i) That length of the Haverfordwest-St. Davids-Goodwick Road (A487) at Croesgoch which extends from a point 275 metres south-west of its junction with the B4330 road to a point 190 metres north-east of that junction.

(ii) That length of the B4330 road at Croesgoch which extends from its junction with the A487 road in a south-easterly direction for a distance of 155 metres.
