

MID GLAMORGAN COUNTY COUNCIL

Mid Glamorgan County Council (Various Streets, Trallwng, Pontypridd) (Revocation) and (Residents Parking Places) Order 1982.

Notice is hereby given that the Mid Glamorgan County Council propose to make an Order under sections 28 (1) and 31 (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972 the effect of which will be as follows:

- (i) to consolidate into one "Residents Only" parking scheme the provisions of the "Mid Glamorgan County Council (Various Streets, Trallwng, Pontypridd) (Residents Parking Places) Order 1980" and the "Mid Glamorgan County Council (North Street, Trallwng, Pontypridd) (Residents Parking Places) Order 1980".
- (ii) to authorise the use of the sides or lengths of roads described in Schedule 1 to this notice as parking places for residents' vehicles only between the hours of 8 a.m. and 6 p.m. Monday to Saturday inclusive. ("Resident" means any person whose usual residence is at premises the postal address of which is in any part of the roads specified in Schedule 2 to this notice.)

Those residents who hold permits which relate to the present scheme operative in North Street, Trallwng, will be issued with fresh permits for the new integrated proposal. Further details concerning their issue will be made known in due course.

As with the two individual schemes now in operation exemptions will be provided in the Order to allow boarding and alighting, loading and unloading, the maintenance of essential services, road works, funerals, weddings and doctors and veterinary surgeons to visit while "on call".

A copy of the proposed Order, a statement of the Council's reasons for proposing to make the Order and a map showing the sides or lengths of roads to which the proposed Order relates may be inspected at the offices of the Taff-Ely Borough Council, Municipal Buildings, Pontypridd, and at the Mid Glamorgan County Hall, Cathays Park, Cardiff, during normal office hours.

Objections to the proposal together with the grounds on which they are made must be sent in writing to the undersigned by 16th August 1982.

SCHEDULE 1

Sides of Lengths of Roads in Trallwng, Pontypridd in the Borough of Taff-Ely

- (a) *West Street*, eastern side, from a point 10 metres (11 yards) north of its junction with South Street, northwards to a point 10 metres (11 yards) south of the southern corner of its junction with North Street, a distance of approximately 86 metres (94 yards) and from a point 10 metres (11 yards) north of its junction with the northern corner of North Street, northwards to the northern boundary of No. 25 West Street, a distance of approximately 68 metres (74 yards).
- (b) *West Street*, western side from a point opposite the southern boundary of No. 14 West Street, northwards to a point 15 metres (16 yards) south of the southern corner of its junction with Fish Lane, a distance of approximately 56 metres (61 yards).
- (c) *Middle Street*, western side from a point 10 metres (11 yards) north of its junction with South Street, northwards to a point 10 metres (11 yards) south of its junction with the southern side of North Street, a distance of approximately 80 metres (88 yards) and from a point 10 metres (11 yards) north of its junction with the north side of North Street, northwards to the northern boundary of No. 30 Middle Street, a distance of approximately 77 metres (84 yards).
- (d) *East Street*, western side from a point 10 metres (11 yards) north of the southern cul-de-sac end northwards to a point 10 metres (11 yards) south of its junction with the southern corner of North Street, a distance of approximately 38 metres (42 yards).
- (e) *East Street*, eastern side from a point 10 metres (11 yards) north of its junction with the northern corner of North Street northwards to a point opposite the southern boundary of No. 24 East Street, a distance of approximately 67 metres (73 yards).

(f) *Sion Street*, eastern side from the southern boundary of No. 1 Sion Street, northwards to the cul-de-sac end of the street, a distance of 386 metres (422 yards).

(g) *North Street*, northern side from a point 10 metres (11 yards) east of its junction with West Street eastwards to the western corner of the lane running between the rears of Nos. 1 and 2 North Street, a distance of approximately 8 metres (9 yards).

(h) *North Street*, northern side from the eastern corner of the lane running between Nos. 1 and 2 North Street eastwards to a point 10 metres (11 yards) west of the north-western corner of Middle Street, a distance of approximately 8 metres (9 yards).

(i) *North Street*, northern side from a point 10 metres (11 yards) east of its junction with Middle Street eastwards to the western corner of the lane running between the rears of Nos. 3 and 4 North Street, a distance of approximately 8 metres (9 yards).

(j) *North Street*, northern side from the eastern corner of the lane running between Nos. 3 and 4 North Street, eastwards to a point 10 metres (11 yards) west of the north-western corner of East Street, a distance of approximately 8 metres (9 yards).

SCHEDULE 2

Roads and Parts of Road for the purpose of the issue of Residents' Permits at Pontypridd in the Borough of Taff-Ely.

(a) *West Street*, Trallwng, from its junction with South Street northwards to the northern boundary of No. 25 West Street.

(b) *Middle Street*, Trallwng, from its junction with South Street northwards to the northern boundary of No. 30 Middle Street.

(c) *East Street*, Trallwng, from the cul-de-sac end northwards to the northern boundary of No. 24 East Street.

(d) *South Street*, Trallwng.

(e) *Sion Street*, Trallwng.

(f) *North Street*, Trallwng.

Mid-Glamorgan County Council (Various Streets, Trallwng, Pontypridd) (Revocation) (Variation) and (Prohibition and Limitation of Waiting) Order 1982.

Notice is hereby given that the County Council of Mid Glamorgan propose to make an Order under sections 1 and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which will be as follows:

- (i) To consolidate into one traffic management measure the provisions contained in the "Mid Glamorgan County Council (Various Streets, Trallwng, Pontypridd) (Revocation, Variation and Prohibition of Waiting) (No. 1) Order 1980" and the "Mid-Glamorgan County Council (North Street, Trallwng, Pontypridd) (Prohibition of Waiting) Order 1980" with the exception that "no waiting" at any time be introduced on the under-mentioned side of length of road, where waiting is currently permitted for a period of 1 hour with return prohibited within 1 hour, between 8 a.m. and 6 p.m., Monday to Saturday inclusive:

The western side of West Street, Trallwng, Pontypridd, from a point 10 metres (11 yards) north of the northern side of its junction with Fish Lane northwards to its junction with The Parade, a distance of approximately 64 metres (70 yards).

- (ii) To revoke and vary certain Road Traffic Regulation Orders made by the County Council and the former Pontypridd Urban District Council, to achieve the intention referred to in (i) above.

Exemptions will be provided in the Order for the purposes of boarding, alighting, loading and unloading, building and roadworks, the maintenance of essential services, weddings, funerals and the delivery or collection of postal packets by vehicles in the service of the Post Office. Disabled persons' vehicles displaying the relevant disabled person's badge will be allowed to wait for up to 2 hours with return prohibited within 1 hour.
