subject to the reservation of pedestrian rights over a 1.83 metres width of the highway along its northern boundary as shown hatched in black on the plan referred to;

(i) the eastern cross street of the former Acclom, Vane and Rodridge Streets from its junction with Acclom Street North Back Street to its junction with Rodridge Street 135 metres or thereabouts in length subject to the reservation of pedestrian rights over a 1-83 metre width of the street along its eastern boundary as shown hatched in black on the plan referred to.

Public Path Creation and Extinguishment Order 1982

Notice is hereby given that the above named Order, made on 27th July 1982, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as an unopposed Order, by the County Council of Humberside.

The effect of the Order, if confirmed without modifications, will be:

- 1. To extinguish the footpath which commences at the junction of Bridleway No. 3 and Footpath No. 1 near the northern corner of Field 0046 and leads in a south-westerly direction for approximately 1,035 metres through Fields 0046, 0024, 6400 and 5584 and to the east of Humber Lock Farm to Weighton Lock.
- 2. To extinguish the footpath which commences at the above point near the northern corner of Field 0046 and leads in a south-westerly direction for approximately 140 metres to the field boundary and then crosses into Field 0024 and runs along its north-western boundary for approximately 180 metres to join Footpath No. 9.
- 3. To extinguish the footpath which commences approximately 150 metres south-east of the northern corner of Field 0046 and leads in a south-westerly direction along the top of a bank for approximately 300 metres, then in a north-westerly direction for approximately 65 metres and then in a south-westerly direction through Field 0024 and along the boundary of Field 7800 and the Old Humber Bank to Weighton Lock.
- 4. To create a bridleway approximately 1070 metres long which commences at the above point near the northern corner of Field 0046 and runs along the north-eastern and south-eastern boundaries of the field, through Field 0024 and along the boundaries of Fields 6400 and 5584 and to the east of Humber Lock Farm to Weighton Lock.
- 5. To create a footpath which commences at the eastern corner of Field 0046 and leads in a south-easterly direction for approximately 100 metres along an existing track to join Footpath No. 9.

A copy of the Order and the map contained in it may be inspected free of charge at the County Council Record Office, County Hall, Beverley and the Boothferry Borough Council offices at Stanhope Street, Goole between the hours of 9 a.m. and 4 p.m. on Mondays to Fridays.
