Notice of Disclaimer Under Section 355 of the Companies Act 1948

Whereas:

(1) Pursuant to Section 353(5) of the Companies Act 1948 Staghurst Ltd (hereinafter called "the Company") became dissolved on the 9th April 1981.

(2) It is alleged that immediately before such dissolution the property disclaimed by this Notice was vested in the Company and may by virtue of section 354 of the Companies Act 1948 be deemed to have become bona vacantia and to have vested in the Crown.

THE HIGHWAYS ACT 1980

The Cardiff—Llangurig Trunk Road (Abercynon—Pentrebach Diversion_Side Roads) Order 1979 (Variation) (No. 2) Order 1982

The Secretary of State for Wales hereby gives notice that, in relation to the above-mentioned trunk road between Abercynon and Pentrebach in the County of Mid Glamorgan, he has made under sections 14, 125 and 326 of the Highways Act 1980 an Order the effect of which is:—

(a) to vary Schedule 3 and Site Plan 3 of the Cardiff-Llangurig Trunk Road (Abercynon-Pentrebach Diversion Side Roads) Order 1979 (that Schedule and Site Plan having been substituted therein by the Cardiff—Llangurig Trunk Road (Abercynon—Pentrebach Diversion Side Roads Order 1979) (Variation) Order 1981) with respect to:—

(i) the stopping up of private means of access to Ty-'n-y-Cae Farm, Pontygwaith and the provision of alternative means of access, and

(ii) the realignment of the proposed means of access to National Coal Board property at Aberfan.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980, or on the ground that any requirement of that Act, or of regulations made thereunder has not been complied with in relation to the Order, may, within 6 weeks from 11th August 1982, or within 6 weeks from the date of publication of this notice, if such period shall expire later, apply to the High Court for the suspension or quashing of the Order or of any provision contrained therein provision contained therein.
