Forbes Place, Bootle

Notice is hereby given that the Council of the Metropolitan Borough of Sefton (as agents for the Merseyside County Council, the Highway Authority for the highway hereinafter mentioned) intend to apply to the South Sefton Magistrates' Court, sitting at Oriel Road, Bootle, on 8th September 1982, at the hour of 2 in the afternoon, for an Order under section 116 of the Highways Act 1980, authorising the highway known as Forbes Place, Bootle, to be stopped up as being unnecessary. The highway to be stopped up is shown edged red on the plan deposited at the Town Hall, Bootle, where it may be inspected free of charge during normal office hours.

The highway to be stopped up is shown cross hatched in black on the plan deposited at the Town Hall, Bootle, where it may be inspected free of charge during normal office hours.
