THE HIGHWAYS ACT 1980

The Raglan-Llandovery Trunk Road (Skew Bridge, Abergavenny to Raglan Village Diversion Side Roads) (Variation Order) 1982.

The Secretary of State for Wales hereby gives notice that, in relation to the above-mentioned Trunk Road between Skew Bridge, Abergavenny, and Raglan Village in the County of Gwent, he has made an Order under sections 14, 125 and 326 of the Highways Act 1980 which is to vary the Raglan-Llandovery Trunk Road (Skew Bridge, Abergavenny to Raglan Village Diversion Side Roads) Order 1976, by deleting provision for the two private means of access across fields to the east of Huntsman's Lane (Route C26-7) near Clytha Park.

Copies of the Order have been deposited at the Welsh Office, Curran Embankment Repository, Curran Embankment, Cardiff; Welsh Office, Transport and Highways Group, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL; at the offices of the Gwent

County Council, County Hall, Cwmbran, Northern Highway Division Roads Depot, Llanfoist, Abergavenny, and the Headquarters Division, Station Road, Raglan, where they are open to inspection free of charge at all reasonable hours.

Copies of the Order the title of which is "The Raglan-Llandovery Trunk Road (Skew Bridge, Abergavenny to Raglan Village Diversion Side Roads) (Variation) Order 1982" can be obtained from the Welsh Office, Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highway Act 1980, or on the ground that any requirement of that Act, or of regulations made thereunder has not been complied with in relation to the Order, may, within 6 weeks from 26th August 1982, or within 6 weeks from the date of publication of this notice, if such period shall expire later apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
