The Trunk Road (Fishguard, Dyfed) (Restricted Roads) Order 1982

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 72 and 73 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit the driving of motor vehicles at a speed exceeding 30 mph in the length of road specified in the Schedule below

A copy of the proposed Order, together with a plan and a statement of reasons for making the Order, may be seen during normal office hours at Dyfed County Council, Area Surveyor's Office, High Street, Fishguard.

That length of the London-Fishguard Trunk Road (A40) at Fishguard in the County of Dyfed which extends from a point 5 metres north-east of its junction with Maesgwynne Road in a general south-westerly direction to a point 205 metres south-west of that junction, being a distance of 210 metres. (2 SI)

#### The Trunk Road (Dinas, Dyfed) (Restricted Roads) Order 1982

Notice is hereby given that the Secretary of State for Wales has made an Order, under sections 72, 73 and 84(D) of the Road Traffic Regulation Act 1967, as amended which shall come into operation on 1st November 1982. The effect of the Order is that the length of road specified in the Schedule to this Notice will become subject to a speed limit of 30 miles per hour.
