HIGHWAYS ACT 1980

The Cardiff-Llangurig Trunk Road (Improvement between RAC Box 487 and Storey Arms) Order 1982

The Secretary of State for Wales hereby gives notice that he has made an Order under section 10 of the Highways Act 1980, the effect of which is to provide 2 lengths of road about 126 and 103 metres in length respectively, which he proposes to construct between RAC Box 487 and Storey Arms near Libanus in the County of Powys which shall become trunk roads as from the date when the Order comes into operation.

Copies of the Order and of the relevant plan have been deposited at Welsh Office, The Repository, Curran Embankment, Cardiff, the Welsh Office, Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, the Offices of Powys County Council, Highways and Transportation Department, Brecon Area Office, The Watton, Brecon and at the Post Office, Libanus, Nr. Brecon, Powys where they are open to inspection free of charge at all reasonable hours.

Copies of the Order, the title of which is "The Cardiff-Llangurig Trunk Road (Improvement between RAC Box 487 and Storey Arms) Order 1982" (S.I. 1982 No.), can be purchased through any bookseller or direct from government bookshops (H.M.S.O.).

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Highways Act 1980 or that any requirement of that Act, or of regulations made thereunder, has not been complied with in relation to the Order, may within 6 weeks from 27th September 1982, or within 6 weeks from the date of publication of this Notice, if such period shall expire later, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
