

- (2) To prohibit vehicles from waiting between the hours of 9 a.m. and 6 p.m. in lengths of Argyle Road and West Street, Bognor Regis.
- (3) To prohibit vehicle from waiting between the hours of 9 a.m. and 6 p.m. on Mondays to Saturdays inclusive in lengths of the following roads in Bognor Regis.  
John Street, Newtown Avenue, Oxford Street and Scott Street.
- (4) To limit waiting to two hours, return prohibited within two hours, between the hour of 8 a.m. and 6 p.m. on Mondays to Saturdays inclusive in lengths of Lyon Street, Bognor Regis.
- (5) To prohibit vehicles from waiting at any time between 1st April and 30th September inclusive in each year in lengths of Cardinals Drive and Nyetimber Lane, Pagham.

Limited exceptions are provided for in the Order for such vehicles as invalid carriages and disabled persons' vehicles. Please study the Order for particulars.

A copy of the Order which will come into operation on 20th October 1982 together with a plan showing the affected lengths of roads, may be inspected at the County Hall, Chichester, during normal office hours.

Any persons who wishes to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, may within 6 weeks from 13th October 1982, apply to the High Court for this purpose.

*The Borough of Test Valley (Various Roads) (Prohibition and Restriction of Waiting) (No. 1) Order 1982*

Notice is hereby given that the Test Valley Borough Council pursuant to arrangements made under section 101 of the Local Government Act 1972 with the Hampshire County Council have made an Order under sections 1(1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, Schedule 6 to the Road Traffic Act 1974 and Schedule 7 to the Local Government, Planning and Land Act 1980, the effect of which will be:

- (1) To prohibit waiting at any time in the following lengths of road:
- (a) *The Avenue*, Andover, on its eastern side, in a northerly direction from its junction with The Pines for a distance of 13 metres.
- (b) *Lynwood Drive*, Andover, on both sides, in a northerly direction from its junction with Weyhill Road for a distance of 15 metres.
- (2) To prohibit waiting between 9 a.m. and 6 p.m. on any day except Sundays, in the following lengths of road:  
*Beales Close*, Andover, on both sides in an easterly direction from its junction with Adelaide Road for a distance of 33 metres.

#### THANET DISTRICT COUNCIL

*The Thanet District Council (Dickens Walk, Broadstairs, Kent) (Prohibition of Waiting) Order 1982*

Notice is hereby given that the Thanet District Council, in the exercise of powers delegated to it by the Kent County Council, the highway authority, has made an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974. The Order will come into effect on 18th October 1982.

The effect of this Order is that you will not be allowed, except upon the direction or with the permission of a police constable in uniform or a traffic warden, to cause or permit any vehicle to wait at any time on any day in Dickens Walk, Broadstairs, Kent.

Exceptions will permit the following:

- (1) Waiting for so long as may be necessary:
- (a) for persons to board or alight;
- (b) for loading or unloading goods;
- (c) when necessary, in connection with:
- (i) building, industrial or demolition operations;
- (ii) the removal of obstructions to traffic;
- (iii) the maintenance of the said sides of road; and
- (iv) the supply of gas, water or electricity or the provision of telegraph lines;
- (d) when necessary, in the service of local authorities or of a water authority in pursuance of statutory powers or duties; and
- (e) for fire brigade, ambulance or police purposes.
- (2) The Waiting of disabled person's vehicles, displaying a disabled person's badge and a parking disc (correctly marked), restricted to 2 hours with return within 1 hour prohibited.

Full details of these proposals are in the Order which, together with a map showing the sides of road concerned and a statement of the District Council's reasons for proposing to make the Order, may be inspected, during normal office hours, at:
