The effect of the Order, if confirmed without modification will be to divert part of the public footpath which leads from Lucastes Lane in a westerly direction to Blunts Wood from a point approximately 300 feet south of the junction of Lincoln Wood and Lucastes Lane extending for a distance of approximately 145 feet, and substituting for that length of path a new length of public footpath, a minimum width of 6 feet, commencing at a point approximately 314 feet south of the junction of Lincoln Wood and Lucastes Lane for a distance of approximately 145 feet in a westerly direction and joining the length of path proposed to be stopped up approximately 180 feet from the point where it meets Blunts Wood.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at Oaklands, Oaklands Road, Haywards Heath, between 9 a.m. and 4 p.m. on Mondays to Fridays inclusive.

Any representation or objection with respect to the Order may be sent in writing to the Chief Executive, Mid-Sussex District Council, Oaklands, Oaklands Road, Haywards Heath, West Sussex, not later than 19th November 1982 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Mid Sussex District Council may, instead of submitting the Order to the Secretary of State for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation, any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

##### NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

##### TOWN AND COUNTRY PLANNING ACT 1971, SECTION 210

*Taunton Deane Borough (Footpath W.G. 17/27c, Wellington) Public Path Diversion Order 1982*

Notice is hereby given that on 6th October 1982 the Taunton Deane Borough Council confirmed the above-named Order.

The effect of the confirmed Order will be to divert approximately 18 metres of public footpath W.G. 17/27c running in a north-westerly direction from a point approximately 30 metres north-west of its junction with Bulford Lane, Wellington onto a new line running in a north-easterly, then north-westerly and then south-westerly direction to rejoin the existing route. The new route will be approximately 35 metres in length.

A copy of the confirmed Order and the map contained in it may be inspected, free of charge, at the Municipal Buildings, Taunton, and at 28 Fore Street, Wellington, during normal office hours.

The Order becomes operative as from the date on which it is certified by the Council that the provisions of Article 2 of the Order have been complied with, but if any person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Town and Country Planning Act 1971 or on the grounds that any requirement of that Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order he may under Schedule 6, paragraph 3 of the Town and Country Planning Act 1971, within 6 weeks from 20th October 1982, make application for the purpose to the High Court.

#### WANSDYKE DISTRICT COUNCIL

##### TOWN AND COUNTRY PLANNING ACTS 1971 TO 1974

##### *Designation of Conservation Area at Northstoke*

Notice is hereby given that the Wansdyke District Council, being the Local Planning Authority, have determined that an area of land at Northstoke is an area of special architectural or historic interest, the character or appearance of which it is desirable to preserve or enhance, and have designated such land as a Conservation Area for the purpose of section 277 of the Town and Country Planning Act 1971.

The Conservation Area is shown edged in black on map No. C.14 which may be inspected during normal office hours on Mondays to Fridays at the Town Hall, Keynsham; the Council's Planning Department, 2 Frome Road, Radstock, and the Treasurer's Department, Council Offices, Westgate Buildings, Bath.

One of the effects of this designation is to prevent the demolition of any building within the Conservation Area, whether or not it is listed as being of special architectural or historic interest, without the express permission of the Local Planning Authority. This control extends to all walls constructed before 1948 and to some walls constructed after that date. Another of the effects is that, with limited exceptions, no person may cut down, top, lop, uproot or wilfully destroy a tree within the Conservation Area without the consent of the Local Planning Authority.
