The County Council of Bedfordshire (Blunham Footpath No. 7) Public Path Diversion Order 1982

Notice is hereby given that on 9th September 1982, the Bedfordshire County Council confirmed the above-mentioned Order.

The effect of the Order, as confirmed, is to divert the following public right of way:

That length of Footpath No. 7 which extends from a point on Grange Road approximately 400 metres north of the junction with Tempsford Road in an easterly direction for a distance of approximately 45 metres and thence in a northerly direction for a distance of approximately 25 metres and thence in a north-easterly direction for a distance of approximately 410 metres; to a path which will extend from a point on Grange Road approximately 395 metres north of the junction with Tempsford Road in an easterly direction for a distance

of approximately 80 metres and thence in a north-easterly direction for a distance of approximately 240 metres and thence in a northerly direction for a distance of approximately 170 metres where it joins the existing Footpath No. 7.

A copy of the Order and the map contained in it has been deposited at the office of the County Secretary at the County Hall, Cauldwell Street, Bedford, and may be inspected free of charge between 9 a.m. and 5 p.m. on weekdays.

The Order becomes operative as from 7th October 1982, but if a person aggrieved by the Order desires to question the validity thereof, or any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980, or on the ground that any requirement of the Act, or of any regulation made thereunder has not been complied with in relation to the Order he may, under paragraph 2 of Schedule 2 to the Act, as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 17th September 1982, make an application for the purpose to the High Court.
