21.—(1) Creating a new benefice of St. Mark, Victoria Park; (2) uniting the benefice of St. Paul with St. Stephen, Old Ford, and the new benefice; and (3) altering the name of the benefice of St. James the Less, Bethnal Green, with St. Mark, Victoria Park, in the diocese of London.

22.—(1) Revoking an earlier Scheme; (2) transferring the parish of Whaddon from the benefice of Brookthorpe with Whaddon and Harescombe to the benefice of St. George, Gloucester; (3) altering the name of that benefice; and (4) creating a new benefice of The Edge, Pitchcombe, Harescombe and Brookthorpe, in the diocese of Gloucester.

23.—(1) Creating a new benefice of Little Waldingfield; (2) uniting it with the benefice of Edwardstone with Groton; and (3) transferring a share of the patronage in the benefice of Acton with Great and Little Waldingfield, in the diocese of St. Edmundsbury and Ipswich.

24.—(1) Transferring the parish of Yarkhill from the benefice of Stretton Grandison with Ashperton, Canon Frome and Yarkhill to the benefice of Tamington with Stoke Edith, Aylton, Pixley, Munsley and Putley; (2) uniting the benefices of Bosbury; Christ Church, Wellington Heath; and Stretton Grandison with Ashperton, Canon Frome and Yarkhill; and (3) uniting the benefices of Colwall and Coddington, in the diocese of Hereford.

25. Uniting the benefices and parishes of Birstall and Wanlip, in the diocese of Leicester.

26. Creating the new benefices and parishes of Westbrook St. Philip (Old Hall and Callands), and Westbrook St. James (Hood Manor), in the diocese of Liverpool.

27.—(1) Revoking a previous Order for holding in plurality the benefices of Barnardiston and Great and Little Wrattling; and

(2) uniting the benefices of Hundon and Barnardiston, in the diocese of St. Edmundsbury and Ipswich.

28. Uniting the benefices of Hollingbourne with Hucking; and Leeds with Bromfield and uniting the parishes of Leeds and Bromfield, in the diocese of Canterbury.

29. Uniting the benefices and parishes of St. Alban, Leicester; St. Mark the Evangelist, Leicester; St. Matthew and St. George, Leicester; St. Michael and All Angels, Belgrave; and St. Gabriel, Leicester, and creating a team ministry for the area of the new benefice, in the diocese of Leicester.

30. Creating a new benefice and parish of Great Crosby All Saints; and establishing a group ministry for the new benefice and the benefice of St. Luke, Great Crosby, in the diocese of Liverpool.

31. Uniting the benefices of Burton-on-Trent, and St. Paul, Burton-upon-Trent, in the diocese of Lichfield.

32. Uniting the benefices of Mamble with Bayton; and Rock with Heightington with Far Forest, in the diocese of Worcester.

33. Uniting the parishes of Great Sampford and Little Sampford, and altering the name of the benefice of Great Sampford with Little Sampford, in the diocese of Chelmsford.

34. Uniting the benefices of Ludham and Potter Heigham, in the diocese of Norwich.

35. Providing a new place of worship for the parish of St. Matthew, Thorpe, in the diocese of Norwich; and declaring redundant the existing parish church and appropriating it and the annexed land for sale for office and residential purposes.

36. Uniting the benefices of Kington with Huntingdon; Old Radnor with Kinnerton; and Knill, in the diocese of Hereford.

37. Declaring redundant the church of St. Stephen, Tovil, in the diocese of Canterbury.

38. Declaring redundant the parish church of Christ Church, Litherland, in the diocese of Liverpool.

39. Creating a new benefice and parish of Appley Bridge, All Saints, in the diocese of Blackburn.

40. Declaring redundant the parish church of St. Cleopas, Toxteth Park, in the diocese of Liverpool.

41. Uniting the benefices of Birtley; and Chollerlton with Thockrington, in the diocese of Newcastle.

42. Uniting the benefices of West Tanfield and Well with Snape, and North Stainley, in the diocese of Ripon.

43.—(1) Uniting the benefices of Collingham; and South Scarle with Girton and Besthorpe;

(2) uniting the parishes of North Collingham and South Collingham; and

(3) uniting the parishes of South Scarle (with Besthorpe), and Girton, in the diocese of Southwell.

44. Declaring redundant the parish church of St. Mark's District in Cheetham, in the diocese of Manchester, and altering the name of the benefice of the same title.

45.—(1) Dissolving the benefice and parish of St. Paul, Bournemouth;

(2) creating a new benefice and parish of Throop; and

(3) altering the areas of the parishes of St. Andrew, Bournemouth; St. Clement, Bournemouth; St. Augustin, Bournemouth; St. Peter with St. Swithun, Holy Trinity and St. Stephen, Bournemouth; St. John the Evangelist, Holdenhurst; and the Holy Epiphany, Bournemouth, in the diocese of Winchester.

46. Altering the areas of the parishes of St. Mary, Southtown and Great Yarmouth, in the diocese of Norwich.

47. Appropriating the redundant church of St. John, Fawley, in the diocese of Hereford, and the annexed land, for sale as a church hall and for other authorised uses.

48. Authorising the sale of the site of the former church of St. Mary, Theydon Bois, in the diocese of Chelmsford, and the annexed land.

49. Making the Redundant Churches Fund responsible for the care and maintenance of the redundant church of St. Peter, Deene, in the diocese of Peterborough.

50. Appropriating the redundant church of St. John the Baptist, Harlow in the diocese of Chelmsford, and the annexed land for leasing as an arts and social centre.

51. Appropriating the redundant church of St. Michael, Upton, in the diocese of Peterborough, for leasing for religious and educational purposes.

52. Authorising the disposal of the site of the former church of St. Paul in the Bail, Lincoln, in the diocese of Lincoln, and annexed land.

53. Making the Redundant Churches Fund responsible for the care and maintenance of the redundant church of St. Nicholas, Ozleworth, in the diocese of Gloucester.

54. Authorising the appropriation and disposal of the redundant church of St. Nicholas, Caenby, in the diocese of Lincoln, and the annexed land, for use as a monument.

55. Appropriating the redundant church of All Saints and St. Barnabas, South Lambeth, in the diocese of Southwark, and the annexed land, for leasing for residential purposes.

56. Appropriating the redundant church of Christ Church, Northam, Southampton, in the diocese of Winchester, and the annexed land, for sale for religious, social and community purposes.

57. Authorising the disposal of the site of the former church of St. Augustine, Newton Heath, in the diocese of Manchester, and the annexed land.

58. Making the Redundant Churches Fund responsible for the care and maintenance of the redundant former parish church of West Oggwell, in the diocese of Exeter.

59. Authorising the disposal of the site and annexed land of the former church of Holy Trinity, South Shields, in the diocese of Durham.

60. Making the Redundant Churches Fund responsible for the care and maintenance of the redundant church of St. Michael, Burwell, in the diocese of Lincoln.

61. Demolishing the redundant church of Holy Trinity, Muckton, in the diocese of Lincoln, and appropriating its site for use as part of the annexed churchyard.

62. Demolishing the redundant Brandon Cemetery Chapel, in the diocese of Durham and appropriating its site to use as part of the annexed churchyard.

63. Appropriating the redundant church of St. George, Old Brentford, in the diocese of London, and part of the annexed land, for leasing for use as a piano museum, and the remainder of the said land and a building thereon for use as a film studio.

64. Authorising the demolition of the redundant church of St. Stephen, Upper Holloway, in the diocese of London, and the disposal of its site and annexed land.
