

WEST LANCASHIRE DISTRICT COUNCIL

The District Council of West Lancashire (Waiting Restrictions at Moorgate and Queen Street, Ormskirk) (Amendment) Order 1982.

Notice is hereby given that the District Council of West Lancashire (hereinafter referred to as "the Council") pursuant to arrangements made under section 100 of the Local Government Act 1972 with the County Council of Lancashire, in exercise of the powers of the said County Council under section 1(1) (2) and (3) of the Road Traffic Regulation Act 1967, as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with section 84C(1) of the Act of 1967 propose to make an Order the effect of which will be:

1. To amend The District Council of West Lancashire (Various Roads, Ormskirk) (Prohibition and Restriction of Waiting) Order 1976 as though that length of Moorgate shown described below were omitted therefrom
2. To introduce a prohibition on waiting at all times on the following lengths of road:

(a) *Moorgate*, on its west side for a distance of 6 metres in a northerly direction from its junction with Queen Street

(b) *Queen Street*, on its north side for a distance of 6 metres in a westerly direction from its junction with Moorgate.

Exemptions will be provided in the Order to enable a vehicle to wait in those lengths of road referred to in the Schedule below for so long as is necessary for a person to board or alight from the vehicle, to enable goods to be loaded onto or unloaded from the vehicle, to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road, or the services therein or if the vehicle is a disabled person's vehicle.

The draft Order, together with a relevant map and a statement of the Council's reasons for proposing to make the Order may be inspected at the Council Offices, Derby Street, Ormskirk during normal office hours.

Objections to the proposal, stating the grounds on which they are made, must be sent in writing to the undersigned by Friday, 10th December 1982.

SANDWELL METROPOLITAN BOROUGH COUNCIL

The Sandwell Borough Council (Hydes Road, Wednesbury) (Prohibition of Waiting) Order 1981

Notice is hereby given that the Sandwell Borough Council, pursuant to arrangements made under section 101 of the Local Government Act 1972, with the County Council of West Midlands in exercise of the powers of the said County Council under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended, have made an Order the effect of which is to prohibit waiting at any time in certain sides of lengths of the following roads:

Hydes Road, Wednesbury;
Woden Road South, Wednesbury.

Exemptions will permit waiting for the purposes of picking up or setting down passengers, loading or unloading goods and in connection with the services of statutory undertakers.

Exemptions will also permit disabled person's vehicles displaying a disabled person's badge to wait for a period of up to 2 hours in those sides of lengths of roads referred to in paragraph 1 above if a parking disc issued by a local authority marking the time at which the period of waiting began is displayed.

The Order was made on 19th November 1982, and comes into effect on 29th November 1982.

A copy of the Order and a map showing the restrictions are available at my offices at the Town Hall, West Bromwich, where they may be examined during normal office hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of the Act or of any Instrument has

not been complied with in relation to the Order, you may within 6 weeks from 22nd November 1982, apply to the High Court for that purpose.
