The Trunk Road (Coryton Interchange) (Clearway) Order
1982

Notice is hereby given that the Secretary of State has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, which shall come into operation on 3rd January 1983. The effect of this Order will be to prohibit (with certain exceptions) the waiting of vehicles in the carriageway of that length of trunk road specified in the Schedule to this notice.

The Order also prohibits trading from the verges and lay-bys of that length of trunk road.

A copy of the Order, together with a plan and statement of reasons for making the Order, may be seen during normal office hours at the offices of the South Glamorgan

County Council, County Headquarters, Newport Road, Cardiff, during a period of 6 weeks from 6th December 1982.

Copies of the Order may be obtained, free of charge, on application to the Welsh Office, Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, quoting ref. TRPC 7/4.

If you wish to question the validity of the Order or of any provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or that any requirement of that Act, or of any Instrument made under it, has not been complied with in relation to the Order, you may, within the aforesaid period of 6 weeks apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
