### SOUTH GLAMORGAN COUNTY COUNCIL

*The County Council of South Glamorgan (Llanfair Road, Canton, Cardiff) (Prohibition of Waiting) Order 1983*

### GWENT COUNTY COUNCIL

*The Gwent County Council (A467 Chepstow Road/Albert Avenue, Newport) (Half Box Junction) Order 1983*

Notice is hereby given that the Gwent County Council in exercise of their powers under the Road Traffic Regulation Act 1967, as amended, and of all other enabling powers propose to make an Order the effect of which will be to create a box junction in accordance with the Traffic Signs Regulations and General Directions 1975 in the areas of carriageways of the roads specified in the Schedule to this Order being areas at or near the junction of two or more of those carriageways.
