The effect of the Order is to:

  - Green Road, from its southern junction with Emerson Road to its northern junction with Emerson Road in a northerly direction,
- (e) close permanently to vehicular traffic, Green Road—commencing at a point 60 feet south of its junction with Lagland Street, to a point 95 feet north of its northern junction with Emerson Road,
- (f) impose restrictions limiting waiting to 2 hours between Monday and Friday, 8 a.m. to 6 p.m. in the following lengths of road:

Emerson Road (north-eastern side) from a point 45 feet south-east of its junction with Emerson Close for a distance of 162 feet in a southerly direction,

Emerson Road (eastern side) from a point 382 feet southeast of its junction with Emerson Close to a point 190 feet north-east of its southern junction with Green Road,

Green Road (north-east side) from a point 144 feet southeast of its northern junction with Emerson Road to a point 45 feet north-west of its southern junction with Emerson Road.

# TYNE AND WEAR COUNTY COUNCIL

Tyne and Wear County Council (Churchill Street/Tynemouth Road, Wallsend) Traffic Regulation Order 1983

Tyne and Wear County Council (Atkinson Terrace, Wallsend) Prohibition of Waiting Order 1983

Notice is hereby given that on 11th April 1983, Tyne and Wear County Council made two Orders under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the Orders which will come into operation on 14th April 1983, are as follows:

- (a) Churchill Street/Tynemouth Road, Wallsend
  - (i) to prohibit waiting at any time by vehicles on that length of the north side of Tynemouth Road, from Churchill Street eastwards for 35 metres, and that length of the south side of Tynemouth Road to the east of Churchill Street which at present is covered by

a zebra crossing. The zebra crossing will be removed and the waiting restriction will be imposed over that area which was the crossing;

(ii) to prohibit any vehicle from proceeding on the unnamed road off the south side of Tynemouth Road opposite Churchill Street, from the junction with Tynemouth Road southwards for 8 metres.

- (b) Atkinson Terrace, Wallsend
- to prohibit waiting at any time on the south side of Atkinson Terrace from a point 21 metres west of Station Road westwards for approximately 72 metres. An exemption permits waiting by Hackney Carriages.

Exemptions to 2(a)(i) and 2(b) above would permit waiting for the purposes of:-

- (a) picking up and setting down passengers,(b) goods to be loaded onto or unloaded from the vehicle,(c) disabled persons' vehicles to wait for up to two hours, and where necessary in connection with:the maintenance of the road, and
- (e) the supply of gas, water or electricity.

Full details are contained in the Orders which together with maps and statements of the Council's reasons for making the Orders may be examined at the offices of:-

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order you may, within 6 weeks from 11th April 1983, apply to the High Court for this purpose.
