Stopping up of Highways at Central Estate, Hartlepool

Notice is hereby given that *Hartlepool Borough Council* as agent for and on behalf of *Cleveland County Council*, the *Highway Authority* intend to apply to the *Magistrates' Court* sitting at the *Law Courts, Civic Centre, Hartlepool* on 18th July 1983 at 10 a.m. for an Order under section 116 of the *Highways Act 1980*, that the following lengths of *Highway* in the *Central Estate, Hartlepool* be stopped up:

- (i) That length of *Watson Street* extending from its junction with *Union Road* in an easterly direction for approximately 220 metres to its junction with *Pease Street*;
- (ii) That length of *Stephenson Street* extending from its junction with *Watson Street* in a southerly direction for a distance of 11 metres;
- (iii) That length of *Bell Street* extending from its junction with *Watson Street* in a southerly direction for a distance of 11 metres;
