#### SOUTH YORKSHIRE COUNTY COUNCIL

*The South Yorkshire County Council (Victoria Street, Sheffield)*  
*(Prohibition of Driving) Order 1983*

Notice is hereby given that on 20th June 1983 the South Yorkshire County Council made an Order under Section 1(1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, Schedule 19 to the Local Government Act, 1972 and Schedule 6 to the Road Traffic Act, 1974.

The effect of the Order which will come into operation on 11th July 1983 will be to prohibit any motor vehicle from proceeding in that length of Victoria Street at Sheffield which extends from its junction with the north kerb line of Broomspring Lane for a distance of 50 metres in a northerly direction.

If you wish to question the validity of the Order or of any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, amended as aforesaid, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order you may within 6 weeks from the 20th June 1983 apply to the High Court for this purpose.

*Extinguishment Order 1983*

Notice is hereby given that on 21st June 1983 the Wolverhampton Borough Council confirmed the above-named Order.

A 1.8 metre wide unsurfaced path commencing at the end of Claistor Drive at a point marked 'C' on the map (Grid reference: 95839761) running in a north-easterly direction for 350 metres to near the Keyway at a point marked 'D' on the map (Grid reference: 96019789) and from thence in a north-easterly direction for 175 metres to the underpass to the Keyway at a point marked 'E' on the map (Grid reference: 95869799).

The Order became operative as from 20th June 1983 but if any person aggrieved by the Order desires to question the validity thereof or of any person contained therein on the grounds that it is not within the power of the Town and Country Planning Act 1971, or on the grounds that any requirement of that Act or any regulation made thereunder has not been complied with in relation to confirmation of the Order, they may under Section 244 of the said Act within 6 weeks from 21st June 1983 make application for the purpose to the Court.
