TREASURY SOLICITOR

*Notice of Disclaimer Under Section 355
of the Companies Act 1948*

Whereas:

(1) Pursuant to section 353 (5) of the Companies Act 1948 Abbotsfield Flats (Wiveliscombe) Ltd. (hereinafter called "the Company") became dissolved on 8th December 1970.

(2) It is alleged that immediately before such dissolution the property disclaimed by this notice was vested in the Company and may by virtue of section 354 of the Companies Act 1948 be deemed to have become bona vacantia and to have vested in the Crown.

(3) It is desired to disclaim the Crown's Title (if any) to the property.

(4) That the property may have vested came to the notice of the Treasury Solicitor on 24th June 1983.

Now therefore I, the Treasury Solicitor, in exercise of the power in that behalf given by section 355 of the Companies Act 1948 do by this notice disclaim the Crown's title (if any) to the property described in the Schedule hereto.

THE SCHEDULE

Property Disclaimed

The lease dated 22nd August 1966 granted by Clarence Harris to the Company of the common parts of the property known as Abbotsfield, Wiveliscombe, Somerset, for a term of 999 years from 30th June 1964 at a peppercorn rent.

THE HIGHWAYS ACT 1980

The London-Fishguard Trunk Road (Pontyfenni to Whitland Diversion) Order 198

The London-Fishguard Trunk Road (Pontyfenni to Whitland Diversion Side Roads) Order 198

The Secretary of State for Wales hereby gives notice that he proposes to make the following:

- (1) An Order under sections 10 and 41 of the Highways Act 1980 providing that a road about 1515 metres in length which he proposes to construct from a point on the trunk road about 80 metres south-west of Ivydene Nurseries to a point on the trunk road approximately 115 metres west of the property known as "Llain" in the County of Dyfed shall become a trunk road as from the date when the Order comes into operation and that the length of the London-Fishguard Trunk Road to be superseded shall cease to be a trunk road as from the date on which notice is given by him to the County Council of Dyfed (who will become the highway authority responsible for that length) that the new trunk road is open for through traffic.
- (2) An Order under sections 14 and 125 of the Highways Act 1980 authorising him:
 - (a) to improve, raise, lower or otherwise alter highways,
 - (b) to stop up highways,
 - (c) to construct a new highway,
 - (d) to stop up a private means of access to premises, and
 - (e) to provide a new means of access to premises.
 all between Pontyfenni and Whitland and providing for the transfer of the new highway to the highway
