#### **PASTORAL MEASURE 1968**

Notice is hereby given that Her Majesty was pleased on 27th July 1983 by Orders in Council to confirm the following Schemes made by the Church Commissioners for:

1. Uniting the benefices of Hawridge with Cholesbury 1. Onling the benefices of Hawridge with Cholesbury; and St. Leonard, Aston Clinton, in the diocese of Oxford, and providing for the new benefice and the benefice of Lee to be held in plurality by one incumbent.

2. Uniting the parishes of Atherstone-on-Stour and Pres-ton-on-Stour, in the diocese of Coventry.

3. Altering the areas of the rural deaneries of Kidder-minster and Stourbridge; and uniting the benefices of Churchill with Blakedown; and Broom, in the diocese of Worcester.

4. Uniting the benefices of Bramshaw; and Landford with Plaitford, in the diocese of Salisbury.

5. Uniting the benefices of Lower Cam and Coaley, in the diocese of Gloucester.

6. Uniting the benefices of Knockholt and Halstead, in the diocese of Rochester.

- 7. (1) Creating a new parish of Syde; (2) altering the name of the parish of Brimpsfield and Syde;
  - (3) creating a new benefice of Cranham;
  - (4) uniting the benefices of Brimpsfield with Elkstone and Syde; and Cranham; and
  - (5) uniting the benefices of Bisley with Oakridge; and Miserden with Edgworth and Cranham, in the diocese of Gloucester.

8. Uniting the benefices of Skirwith with Ousby and Melmerby; and Kirkland, in the diocese of Carlisle.

- 9. (1) Creating a new parish of Copston Magna;
  (2) altering the name of the parish of Withybrook with Copston Magna;
  - (3) rearranging the benefices and parishes of Burton Hastings; Stretton Baskerville; Wolvey; Bulking-ton; Shilton with Ansty; Wolvey with Burton Hast-ings and Stretton Baskerville; and Withybrook with Copston Magna; and
  - (4) establishing a group ministry for the benefices of Bulkington with Shilton and Ansty; and Wolvey

with Burton Hastings, Copston Magna and Withybrook, in the diocese of Coventry.

10. Uniting the benefices of Moreton and Bobbingworth, in the diocese of Chelmsford.

- 11.(1) Dissolving the benefices of Hook with Greywell; and Newnham, Nately Scures and Mapledurwell with Up Nately;
  - (2) creating a new benefice of Hook; and
  - (3) creating a new benefice and parish of Newnham with Nately Scures with Mapledurwell with Up Nately with Greywell, in the diocese of Winchester.

12. Uniting the benefices of Little Ellingham with Great Ellingham; and Rockland St. Peter with All Saints and St. Andrew, in the diocese of Norwich.

- 13.(1) Dissolving the benefice of St. Faith, North Wilford
  - (2) declaring redundant the parish church of St. Faith, North Wilford and appropriating it and the annexed land for sale for use by the Elim Pentecostal Church ; and
  - (3) altering the areas of the parishes of St. George with St. John the Baptist, Nottingham, St. Saviour, Nottingham and St. Faith, North Wilford, in the diocese of Southwell.

14. Uniting the benefices of Whittington and Weeford, in the diocese of Lichfield.

15. Uniting the benefices of Harbury and Ladbroke, in the diocese of Coventry.

16. Uniting the benefices and parishes of St. Philip and St. James with St. Andrew, Plaistow; and St. Mary, Plaistow, in the diocese of Chelmsford, and establishing a team ministry for the new benefice.

17. Uniting the parishes of Ottringham and Sunk Island, in the diocese of York, and declaring redundant the parish church of Sunk Island.

18. Vesting part of the parish burial ground of Uley with Owlpen, in the diocese of Gloucester, in the Diocesan Board of Finance for disposal.

19. Appropriating part of the churchyard of the parish church of St. George, Ovenden, in the diocese of Wakefield, for ecclesiastical purposes.

20. Altering the areas of the parishes of Christchurch, Lichfield; Chad, Lichfield; St. Mary, Lichfield; St. Michael, Lichfield; and Whittington, in the diocese of Lichfield.
