The City of Carlisle (Hespek Raise) (Prohibition of waiting) Order 1983

Notice is hereby given that the Council of the City of Carlisle pursuant to arrangements made under section 101 of the Local Government Act 1972 with the County Council of Cumbria in exercise of the powers of the said County Council under section 1(1) (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 Schedule 19 to the Local Government Act 1972 and Schedule 6 of the Road Traffic Act 1974 and after consultation with the Chief Officer of Police intends to the following services. intend to make an Order to introduce the following waiting restrictions:

The intention of the Order is to prohibit vehicles from waiting at any time on the western side of Hespek Raise for its full length and on its eastern side for a distance of 20 metres from the junction with Geltsdale Avenue from a point 60 metres from the junction with Geltsdale Avenue for 25 metres in a southerly direction from a point 125 metres from the junction with Geltsdale Avenue for a point 125 metres from the junction with Geltsdale Avenue for a point 125 metres from the junction with Geltsdale Avenue for a point 190 metres from the junction southerly direction from a point 190 metres from the junction with Geltsdale Avenue for a distance of 25 metres in a southerly direction and from a point 255 metres from the junction of Geltsdale Avenue for 25 metres in a southerly direction.

These lengths of Hespek Raise on its east side on which No Waiting will be allowed at any time will be interspersed by unrestricted lengths of road.

#### GREATER MANCHESTER COUNTY COUNCIL

The Parking Places and Controlled Parking Zone (Manchester) Order 1971 (Variation) Order No. 31 1983.
