The Fishguard-Bangor (Menai Suspension Bridge) Trunk Road (Improvement at Pont Rhyd, Llwynceilyn Side Roads) Order 198

The Secretary of State for Wales hereby gives notice that he proposes, in relation to the above-mentioned Trunk Road between Pont Rhyd and Llwynceilyn in the Communi-

ties of Llanarth and Llanina in the county of Dyfed, to make under sections 14 and 125 of the Highways Act 1980 an Order which will:

(a) authorise him:

- (i) to improve, raise, lower or otherwise alter highways,
- (ii) to stop up lengths of highways,
- (iii) to construct a new highway,
- (iv) to stop up private means of access to premises, and
- (v) to provide new means of access to premises, all between Pont Rhyd and Llwynceilyn aforesaid; and

(b) provide for the transfer of the said new highway to the County Council of Dyfed as from the date on which he notifies the Council that the new highway has been completed and is open to through traffic.
