

2. Goldsmith Avenue—
south side, outside Nos. 23 to 29, to protect the proposed new bus stop outside No. 29.
3. Whitstable Road—
both sides, at its junction with Sevenoaks road.

The Borough of Sunderland (Junction of Toward Road/South Back Gray Road) Traffic Regulation Order 1983
