Sea Defences, Hill Head, Fareham, Hants

Notice is hereby given that the Fareham Borough Council acting in their capacity as Coast Protection Authority hereby give notice under sub-section (1) of section 5 of the Coast Protection Act 1949 that they propose to carry out coast protection works as described herein at Hill Head, Fareham, in Hampshire.

The site of the proposed works is to the east of Hill Head Sailing Club, Cliff Road, extending eastwards for a distance of approximately 120 metres to the existing concrete sea wall. In order to prevent erosion of the bank supporting Cliff Road, it is intended to provide a new length of sea wall comprising part gabion and part bagged concrete construction. An additional groyne is also being contructed, Plans of the work may be inspec-ted at the offices of the Director of Technical Services, Civic Offices, Fareham, during normal office hours. estimated cost of the works is £70,000.

The Langbaurgh (High Street, Skinningrove) (Prohibition of Driving) Order 1983

#### NEW FOREST DISTRICT COUNCIL

District of New Forest (The High Street, Lymington) (Prohibition of Waiting) Order 1983

Notice is hereby given that the District Council of New Forest pursuant to arrangements made under section 101 of the Local Government Act 1972 with the County Council of Hampshire in exercise of the powers of the said County Council propose to make an Order under sections 1 (1), (2), (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, by Schedule 19 to the Local Government Act 1972 and by Schedule 6 to the Road Traffic Act 1974.

The effect of this Order will be to prohibit the waiting by vehicles on the south side of the High Street, Lymington, from its junction with Gosport Street to a point 30-5 west thereof.

Exceptions in the Order will permit waiting for the purposes of picking up and setting down passengers, loading and unloading goods and, where necessary, in connection with the maintenance of roads and the supply of gas, water and electricity.
