ACQUISITION OF LAND ACT 1981

The Greater London (Hayes By-Pass, Ealing, Hillingdon and Hounslow) Compulsory Purchase Order 1983 Open Space Land East of Yeading Brook and West of the Parkway and South of Hayes Road.

The Greater London Council have submitted this Compulsory Purchase Order to the Secretary of State for Transport which, if confirmed will authorise them to purchase land which forms part of an open space as defined in the above-mentioned Act. This land is described in the Schedule hereto and is shown coloured pink on the map referred to in paragraph 4 below.
