#### BASILDON DISTRICT COUNCIL

##### *The District of Basildon (Road 70, Basildon) (Prohibition of left and right turns) Order 1983.*

Notice is hereby given that the District Council of Basildon, pursuant to arrangements made with the Essex County Council under Section 101 of the Local Government Act 1972 and in exercise of the powers of the County Council under Section 1(1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 have made on 29th September, 1983 a Traffic Order as follows:—

To prohibit all vehicles from making the following left and right turns at the junctions of Road 70 with Lower Dunton Road and the access road for the Vehicle Research Centre:

- Road 70 north-bound, left turn into Lower Dunton Road;
- Road 70 north-bound, right turn into slip road (to Lower Dunton Road) from south-bound carriageway; and
