**NOTICE**

The Treasury in pursuance of section 5 of the National Loans Act 1968 (as amended) hereby give notice that on or after 26th October 1983.

- I. Different rates of interest shall apply according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.), or by instalments of equal repayments of the principal and interest paid thereon (E.R.);
- II. The lowest rates of interest satisfying the conditions laid down in subsection (3) of the said section 5 shall be:

**MISUSE OF DRUGS ACT 1971, SECTIONS 13 AND 14**

*Direction Prohibiting Exercise of Powers in relation to  
Controlled Drugs*

*Mosehuddin Mahmood*

Notice is hereby given, in accordance with section 16 (2) of the Misuse of Drugs Act 1971, that the Secretary of State has given the following direction, which came into effect on 20th October 1983:

The Secretary of State, in pursuance of subsection (2) of section 13 of the Misuse of Drugs Act 1971, and in accordance with section 14 of that Act, by this direction, prohibit Dr. Mosehuddin Mahmood, M.B., B.S. a doctor within the meaning of the Act, whose registered address is 16 Freston Gardens, Cockfosters, Barnet, Hertfordshire, from prescribing, administering and supplying and from authorising the administration and supply of any controlled drug with the meaning of that Act.

This direction does not extend to the doing of anything in circumstances in which it may lawfully be done without being a doctor.
