

**RATES OF INTEREST ON LOANS FROM
THE NATIONAL LOANS FUND**

NOTICE

The Treasury in pursuance of section 5 of the National Loans Act 1968 (as amended) hereby give notice that on or after 2nd November 1983:

- I. Different rates of interest shall apply according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.), or by instalments of equal repayments of the principal and interest paid thereon (E.R.);
- II. The lowest rates of interest satisfying the conditions laid down in subsection (3) of the said section 5 shall be :

The Trunk Road (A40) (Carmarthen, Dyfed) (40 m.p.h. Speed Limit) Order 1983

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 74 and 84D of the Road Traffic Regulation Act 1967, as amended, the effect of the proposed Order will be that the length of road specified in the Schedule to this notice will become subject to a speed limit of 40 miles per hour.

That length of the London-Fishguard Trunk Road (A40) at Carmarthen in the County of Dyfed which extends from a point 273 metres west of its junction with the access road to the Dyfed-Powys Police Headquarters in a general westerly direction for a distance of 60 metres. (2 SI)

The Trunk Road (A55) (Coed-y-Cra, Halkyn, Clwyd) (Prescribed Routes) Order 198

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended.

The effect of the proposed Order will be to prohibit vehicles proceeding in the eastbound carriageway of the Chester-Bangor Trunk Road (A55) at Coed-y-Cra, Halkyn, in the County of Clwyd from making a right-hand turn into the unnamed access road leading to the Little Chef Restaurant and also to prohibit U-turns at this location.

Exceptions have been included in the proposed Order for emergency vehicles.
