The Trunk Road (A487) (Rhydypennau, Dyfed) (Restricted Roads and 40 m.p.h. Speed Limit) Order 1983

Notice is hereby given that the Secretary of State for Wales has made an Order under sections 72, 73, 74 and 84D of the Road Traffic Regulation Act 1967, as amended, which shall come into operation on 18th November 1983.

The effect of the Order is that no person shall cause or permit any motor vehicle to proceed at a speed exceeding 40 miles per hour in the length of road specified in the Schedule to this notice.

A copy of the Order, a copy of the Order to be revoked, together with a plan and statement of reasons for making the Order, may be seen during normal office hours at the offices of the Ceredigion District Council, Town Hall, Aberystwyth, during a period of 6 weeks from 4th November 1983.
