## The Trunk Road (A35) (Bridport, Dorset) (Box Junction) Order 1983

Notice is hereby given that the Secretary of State for Transport has made an Order under section 1 (1), (2), (3) and (3B) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974, on the Folkestone-Honiton Trunk Road (A35) at Bridport in the District of West Dorset in the county of Dorset. The Order comes into force on 20th January 1984.

The effect of the Order is to impose box junction restrictions on the junction of that length of the trunk road known as West Allington with Park Road. These restrictions are designed to ensure that this junction is not obstructed by queuing traffic and thus will safeguard free and unimpeded access to and from both the Hospital
