### NEW TOWNS ACT 1981

*Central Lancashire Development Corporation Extinguishment of Public Rights of Way, Part of Midgery Lane, Preston.*

Notice is hereby given that the Secretary of State for the Environment in exercise of his powers under section 23 of the New Towns Act 1981, has made an Order extinguishing the public rights of way over the following route shown hatched black on the map hereinafter referred to:

"That part of Midgery Lane starting from a point marked "A" on the map approximately 440 yards south-east of its junction with D'Urton Lane, running in a south-easterly direction for a distance of approximately 640 yards to a point marked "B" on the map approximately 200 yards south of 'My Uncle's Farm.'"

The Order is dated 7th December 1983 and a copy of it and of the map referred to in it showing the rights of way which have been extinguished may be inspected at the offices of the Central Lancashire Development Corporation, Cuerden Hall, Bamber Bridge, Preston.
