

NEW GENERAL LICENCES

- (a) Licence No. TAY/GEN/84/5 (in England).
 - (b) Licence No. WOAD/GEN/84/1 (in Wales).
- Country: Federal Republic of Germany.
 Subject of Licences: Whole Fresh Shell Eggs.
 The licences are valid for importation through
- (a) all ports and airports in England, and
 - (b) all ports and airports in Wales.

Conditions attached to licences above

A. Each consignment must be accompanied by a certificate signed by an official veterinarian of the Federal Republic of Germany stating:

I. IDENTIFICATION OF THE BATCH

- Nature and marking of packaging
- Number of packs

II. ORIGIN OF THE EGGS

- (i) Address and registration number of the packing station

- (ii) Address(es) of premises of origin

III. DESTINATION OF THE EGGS

IV. HEALTH CERTIFICATION

- (1) No case of Newcastle disease has occurred on the holdings or origin of the eggs for more than 6 months.
- (2) The holdings of origin are situated at the centre of an area with a 10 km radius within which no case of Newcastle disease has been recorded for than 1 month.
- (3) None of the poultry on the holding from which the eggs destined for export came had been vaccinated against Newcastle disease during the four weeks prior to the despatch of the eggs from the holding.
- (4) The cardboard boxes, trays or other containers containing eggs coming from holdings which satisfy the conditions above are new.
- (5) The cardboard boxes or other containers containing eggs are marked with the registration numbers of the packing station(s) and the address(es) of the premises of origin.
- (6) The eggs obtained in accordance with the conditions above have been stored and transported separately from other eggs as agreed with the competent central authority.

B. Any eggs imported under this licence shall be made available if so required for inspection by an Officer of the Ministry at any place nominated by him for such inspection. The importer or his agent shall afford all assistance necessary to such an officer to enable him to carry out the inspection in such manner as he shall determine and the importer shall be responsible for meeting any costs of carrying out such an inspection.

NOTES:

(1) Nothing in this licence gives exemption from any prohibition or restriction imposed by the Imported Food Regulations 1968 or the Medicines Acts 1968 and 1971 or by any regulation superseding or amending the same, or any prohibition, regulation or restriction imposed by the Department of Trade and Industry or any other legal prohibition or restriction.

(2) This is not a Department of Trade and Industry licence.

IMPORTATION OF ANIMAL PRODUCTS AND POULTRY PRODUCTS ORDER 1980 (AS AMENDED)

Notice is hereby given that as provided by Article 4 of the Importation of Animal Products and Poultry Products Order 1980, as amended, the Ministry of Agriculture, Fisheries and Food, and the Welsh Office Agriculture Department did on 16th November 1983 issue the following General Licences with product headings and conditions as detailed below:

Subject: UHT Milk, UHT Cream and UHT Milk-based Drinks.

Countries: Belgium, Denmark, Federal Republic of Germany, France, Luxembourg, Netherlands and Republic of Ireland.

Licences are valid through:

- (a) Avonmouth, Dover (Eastern Dock), Felixstowe, Folkestone, Gatwick, Grimsby, Harwich (Parkestone Quay), Heysham, Liverpool, London (Tilbury), Newhaven, Plymouth, Poole, Sheerness, Southampton, Tyne (North Shields)—(in England).
- (b) Cardiff—(in Wales).

Conditions attached to licence A.

A. Each consignment must be accompanied by a certificate entitled Animal Health Certificate and signed by a duly authorised Veterinary Officer of the Government of the country of origin stating:

- (i) the details of consignment including consignee, consignor, premises of origin, description of product and quality; and
- (ii) that the product was treated to a temperature of at least 135°C for a period of at least 1 second.

B. The Animal Health Certificate specified in clause A must be presented to Her Majesty's Customs and Excise at the port of landing.

Subject: Sterilised Milk and Sterilised Milk-based Drinks.

Subject: UHT Milk, UHT Cream and UHT Milk-based Drinks.

Country: Northern Ireland.

Licences are valid through all ports and airports in England.

Conditions attached to Licence C.

A. Each consignment must be accompanied by a certificate signed by a Veterinary Officer of Northern Ireland duly authorised by the Department of Agriculture for Northern Ireland stating:

- (i) the details of consignment including consignee, consignor, premises of origin, description of product and quantity; and
- (ii) that the product was treated to a temperature of at least 135°C for a period of at least 1 second.

B. The Certificate specified in clause A must be presented to Her Majesty's Customs and Excise at the port of entry.
