ROAD TRAFFIC ACTS

AVON COUNTY COUNCIL

The County of Avon (Hotwell Road Area, Hotwells, Bristol) (Prohibition and Restriction of Waiting) Order 1984.

Notice is hereby given that on 7th February 1984, the County Council of Avon made an Order under sections 1 (1), (2), (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended, the effect of which is:

- (1) to prohibit any vehicle waiting at any time in the lengths of road specified in Schedule 1 to this notice;
- (2) to prohibit any vehicle waiting between the hours of 8 a.m. and 6 p.m., Monday to Saturday (inclusive), in the lengths of road specified in Schedule 2 to this notice;
- (3) to prohibit any vehicle waiting:
 - (a) between the hours of 8 a.m. to 9.15 a.m. and 4.45 p.m. to 6 p.m. on Monday to Friday (inclusive);

(b) for more than 1 hour in any 2 hourly period between the hours of 9.15 a.m. and 4.45 p.m. on Monday to Friday (inclusive);

(c) for more than 1 hour in any 2 hourly period between the hours of 8 a.m. and 6 p.m. on Saturdays

in the lengths of road specified in Schedule 3 to this notice.

(4) to prohibit any vehicle waiting for more than 1 hour in any 2 hourly period between the hours of 8 a.m. and 6 p.m. on Monday to Saturday (inclusive) in the lengths of road specified in Schedule 4 to this notice.

(5) to prohibit any vehicle loading or unloading goods between the hours of 8 a.m. and 9.15 a.m. or between the hours of 4.45 p.m. and 6 p.m. on Monday to Friday (inclusive) in the lengths of road specified in Schedule 5 to this notice.

(6) to vary provisions of Orders currently in operation to give effect to the above measures.

The Order will come into operation on 20th February 1984 and a copy thereof together with a map may be inspected at the under-mentioned offices (6th Floor), during normal office hours.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers of the relevant section of the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, may within 6 weeks after the date on which the Order was made, apply to the High Court for this purpose.

Ambra Vale, both sides, from Hotwell Road for 18 metres.
Clifton Vale, both sides, from Hotwell Road for 15 metres.
Hotwell Road, east, north-west and north side:

(a) from the Portway to the western carriageway of Dowry Square, except that length which extends from a point 18 metres south of its junction with Hope-chapel Hill in a southerly direction for 13 metres;

(b) from a point 15 metres west of its junction with Clifton Vale to a point 85 metres east of Ambra Vale;

(c) from Jacobs Wells Road/Hotwell Road roundabout in a westerly direction for 80 metres.
West, south-east and south side:

(a) from the Portway to the southern end of the lay-by fronting premises numbered 287 to 299 Hotwell Road;
