

The effect of the proposed Order will be to prohibit waiting at any time on any day on the side of the trunk road specified in the Schedule to this notice.

Exceptions in the proposed Order will permit waiting for the following reasons:

- (a) picking up or setting down passengers;
- (b) loading or unloading goods;
- (c) building, industrial or demolition operations; and
- (d) carrying out essential services connected with the maintenance of the road and the supply of gas, water and electricity.

The usual exceptions have also been provided in the proposed Order for vehicles displaying a disabled person's badge.
