

Unless the Order is suspended or quashed as a consequence of any such application, any person who on 20th February 1984 has an interest in land having lawful access to a highway to which the Order relates may claim to be entitled to be compensated by the Nottingham City Council in respect of any depreciation in the value of his or her interest which is directly attributable to the Order and of any other loss or damage which is so attributable. Any claim must be served on the Council at its above address within a period of 6 months from 20th February 1984 unless the period is extended in any particular case by the Secretary of State.

THE IMPORTED FOOD REGULATIONS 1968, AS AMENDED

Yugoslavia: Official Certificates

The Minister of Agriculture, Fisheries and Food and the Secretary of State for Wales acting jointly in exercise of the powers conferred on them by the Imported Food Regulations 1968 (S.I. 1968 No. 97), as amended by the Imported Food (Amendment) Regulations 1973, 1979 and 1981 (S.I. 1973 No. 1351, S.I. 1979 No. 1426 and S.I. 1981 No. 1085) give notice that they hereby recognise, subject to the conditions hereinafter set out, the Official Certificates described in Part 1 of the Schedule hereto for the importation from Yugoslavia of meat and meat products and poultry meat and poultry meat products as showing:

- (a) that the meat or poultry meat to which they relate, or the meat or poultry meat from which the meat product to which they relate was prepared, was derived from mammals or poultry inspected before and after death in the country of origin of the meat and passed in accordance with criteria satisfactory to the Ministers; and

- (b) that the dressing, packing and other preparation of the meat or poultry meat was carried out with all necessary precautions for the prevention of danger to health.

1. Recognition of the Official Certificate is extended to include:

- (a) meat, with or without bone, which contains no associated lymphatic glands, or from which any pleura, peritoneum or lymphatic gland has been removed; and
(b) portions of carcasses with or without bone, comprising recognisable wholesale or retail cuts which contain no associated lymphatic gland or from which has been removed, in preparing or trimming the meat, any pleura, peritoneum or lymphatic gland.

The recognition does not extend to boneless veal appearing to an authorised officer to be from calves less than three months old.

SCHEDULE

Part 1

- (a) For meat, the Official Certificate shall consist of a stamp or label bearing the following details within an oval surround 6.5 centimetres wide by 4.5 centimetres high:

On the upper part:

the name Yugoslavia in capitals or, if appropriate the set of initials approved for that country under the International Convention on Motor Vehicle Registration, viz: YU.

In the centre:

the number of the establishment, which shall be one of those listed in Part 2 of this Schedule.

The letters must be 0.8 centimetres high and the figures 1 centimetre high. The seal may include an indication of the official Veterinarian who carried out the health inspection of the meat.

- (b) For poultry meat and

(c) For meat products including canned meats but excluding meat products derived in whole or in part from poultry meat and

(d) For poultry meat products derived in whole or in part from poultry meat

A label or stamp in the form below:



The Official Certificate will be completed by the insertion of the establishment number which shall be one of those listed in Parts 3 and 4 of this Schedule.
