## ROAD TRAFFIC ACTS

### ASHFORD BOROUGH COUNCIL

*The Ashford Borough (Curtis Road, South Wittlesborough, Ashford) (Prohibition of Driving) Order 1984*

Notice is hereby given that on 16th February 1984, the Ashford Borough Council pursuant to arrangements made under section 101 of the Local Government Act 1972 with Kent County Council made an Order under sections 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972.

When this Order comes into operation on 16th February 1984 no person shall cause or permit any vehicle to enter or leave Curtis Road, South Willesborough, Ashford, Kent at its junction with Bath Road.

If any person wishes to question the validity of the Order or any provision contained in it on the ground that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, that person may, within 6 weeks from 16th February 1984 apply to the High Court for this purpose.
