

## HERTFORDSHIRE COUNTY COUNCIL

*The Hertfordshire (A412, Uxbridge Road, Rickmansworth) (Prohibition of Waiting) Order 1984*

Notice is hereby given that the Hertfordshire County Council have made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended. This Order, which comes into operation on 5th March 1984 will have the effect of prohibiting at any time on a length of the south side of Uxbridge Road, Rickmansworth, opposite its junction with Nightingale Road.

The usual exemptions will apply to enable persons to board or alight, for goods to be loaded or unloaded, for disabled drivers and for vehicles engaged in maintenance statutory duties or the emergency services.

A copy of the sealed Order and a plan showing the road to which the Order relates, may be inspected at the offices of the Three Rivers District Council, 17-23 High Street, Rickmansworth, and at Room 204, County Hall, Hertford, during normal office hours.

Any person wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act, or of any Instrument made under it, has not been complied with in relation to the Order may, within 6 weeks from the date of this notice apply to the High Court for this purpose.

## HERTFORDSHIRE COUNTY COUNCIL

*The Hertfordshire (Delmerend Lane/Lybury Lane, Flamstead) Weight Restriction Consolidation and Variation Order 1984.*

Notice is hereby given that on 29th February 1984 the Hertfordshire County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which is to vary the county of Hertford (Delmerend Lane/Lybury Lane, Flamstead) (Weight Restriction) Order 1973, made by the Hertfordshire County Council on 2nd February 1973, as follows:

- (1) In that Order, there shall be substituted for the prohibition on the use of vehicles the weight of which exceeds 2 tons unladen a corresponding prohibition of vehicles the (metric equivalent) weight of which exceeds 5 tonnes gross vehicle weight.
- (2) The exemption provided in the 1973 Order for the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to the lengths of road specified shall be replaced by a clause enabling vehicles to proceed in the said lengths of road for the purposes of loading or unloading the said vehicle at premises which are on or adjacent to the roads specified in the Schedule.

A copy of the Order, which comes into operation on 3rd March 1984, and a plan showing the road to which the Order relates, may be inspected at the Library, Lamb Lane, Redbourn and at Room 204, County Hall, Hertford, during normal opening hours.

Any person wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act, or of any Instrument made under it, has not been complied with in relation to the Order may, within 6 weeks from the date of this notice apply to the High Court for this purpose.

## EAST HERTFORDSHIRE DISTRICT COUNCIL

*Traffic Regulation Orders*

Notice is hereby given that the East Hertfordshire District Council have made 2 Orders under the provision of section 1 (1), (2) and (3) of the Traffic Regulation Act 1967, as

amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 of the Road Traffic Act 1974 the effect of which is to:

- (1) *Portland Place and Portland Road, Bishop's Stortford (Prohibition of Waiting) Order (No. 81) 1981*

Prohibit waiting between the hours of 8.30 a.m. to 6.30 p.m. on Mondays to Saturdays, on the south side of Portland Place, from the junction of Portland Road to the eastern extremity of the carriageway in Portland Place, Bishop's Stortford.

- (2) *Star Street, Ware (Prohibition of Waiting) Order (No. 86) 1982*

Prohibit waiting between the hours of 8 a.m. to 6.30 p.m. Monday to Saturday on the north side of Star Street from its junction with Bowling Road, Ware, for a distance of approximately 150 metres up to its junction with Clement Street, Ware.

A copy of the Orders and plans showing the proposals together with a statement of the Council's reasons for making the Orders may be examined at the Council Offices, 2 The Causeway, Bishop's Stortford, or at Vale House, Cowbridge, Hertford (between 9 a.m. and 5 p.m. Monday to Friday).

Any person who desires to question the validity of the Orders or of any provision contained in the Orders in (1) and (2) above, on the grounds that it is not within the powers of the relevant section of the Act, or on the grounds that any requirement of that section or of section 84A, 84B or 84C of the Act or any regulations made under the said section 84C have not been complied with in relation to the Orders in (1) and (2) above, may, within 6 weeks from 2nd March 1984, make application for the purpose to the High Court.

## HUMBERSIDE COUNTY COUNCIL

*The County of Humberside (Boothferry Borough) (Goole By-pass and Trent Street) (Prohibition and Restriction of Waiting and Prohibition of Driving) Order 1984.*

Notice is hereby given that on 23rd February 1984 the Humberside County Council made this Order which will be operative from 26th March 1984 and the effect of which will be:

- (a) to prohibit vehicles to wait at any time on both sides of the Goole By-pass for a distance of 50 metres from its junction with Bridge Street;
- (b) to prohibit any motor vehicle to enter or leave Trent Street at its junction with Bridge Street;
- (c) to revoke the whole of Schedule 4 to the County of Humberside (Boothferry Borough) (Various Streets, Goole) (Prohibition and Restriction of Waiting and One-Way Traffic) Order 1979.

Exceptions to (a) above will include permission to wait for the purpose of picking up and setting down passengers, loading and unloading of goods, the maintenance of roads, gas, water and electricity supplies and for fire, police and ambulance purposes.

A copy of the Order and relevant map may be inspected during normal office hours at the Administration Department, County Hall, Beverley (ref. BAS/8915), and Boothferry Borough Council, Council Offices, Stanhope Street, Goole.

If you wish to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from 23rd February 1984 apply to the High Court for this purpose.
