

## SOUTH YORKSHIRE COUNTY COUNCIL

*The South Yorkshire County Council (Rural Lane, Wadsley) (Prohibition of Waiting) Order 1984*

Notice is hereby given that the South Yorkshire County Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the proposed Order will be to prohibit waiting by vehicles at any time in that length of the west side of Rural Lane at Wadsley which extends from a point 18 metres south of its junction with the southern kerb-line of Luke Lane for a distance of 40 metres in a northerly direction.

Exceptions to the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods, in connection with building, industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the services therein, in pursuance of statutory powers or duties and for the collection and delivery of postal packets. The usual exceptions for disabled persons' vehicles are also included in the Order.

A copy of the proposed Order together with a map showing the restricted road and a statement of the County Council's reasons for proposing to make the Order may be examined during normal office hours at the offices of (i) the County Council, County Hall, Barnsley, (ii) County Engineer, Arundel House, Furnival Gate, Sheffield, and (iii) Sheffield City Council, Branch Library, Middlewood Road, Sheffield.

If you wish to object to the proposed Order you should send the grounds for your objection in writing to the undersigned by 28th March 1984.

*The South Yorkshire County Council (Clarke Street and Brunswick Street, Sheffield) (Prohibition of Waiting) Order 1984.*

Notice is hereby given that the South Yorkshire County Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

## NOTICE OF PUBLIC PATH ORDER

## TOWN AND COUNTRY PLANNING ACT 1971, SECTION 210

*The Borough of Tamworth (Part of Footpath No. T.80, Dosthill) Public Path Diversion Order 1984*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 23rd February 1984 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Tamworth Borough Council, as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public right of way running from a point on East Street, Dosthill, approximately 25 metres east of its junction with High Street, Dosthill, to a point some 205 metres generally in a south-easterly direction along the existing route to a line running from the said point on East Street, Dosthill, to a point some 230 metres generally in a south-easterly direction along estate footways and then some 40 metres in a northerly direction to join the original route.

A copy of the Order and the map contained in it has been deposited at the Municipal Offices, Marmion House, Lichfield Street, Tamworth, and may be inspected free of charge between the hours of 9 a.m. and 5 p.m. Mondays to Fridays. Copies of the map and Order may be purchased.

Any representation or objection to the Order may be sent in writing to the Tamworth Borough Council, Municipal Offices, Marmion House, Lichfield Street, Tamworth, not later than 5th April 1984 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Tamworth Borough Council may instead of submitting the Order to the Secretary of State for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.
