

SCHEDULE

Gleadless Road, north-east side, from a point 15 metres north-west of its junction with the north-west kerb-line of *Hartley Street* to a point 50 metres southeast of its junction with the south-east kerb-line of *Hartley Street*.

Hartley Street, both sides, from its junction with the north-eastern kerb-line of *Gleadless Road* for a distance of 15 metres in a north-easterly direction. (A.K.) (482)

SOUTH YORKSHIRE COUNTY COUNCIL

The South Yorkshire County Council (Various Roads at Sheffield) (Area No. 7) (Amendment No. 11) Order 1984.

Notice is hereby given that on 7th March 1984 the South Yorkshire County Council made an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the Order which will come into operation on 19th March 1984 will be to prohibit waiting by vehicles in any of the sides of road specified in the Schedule to this notice.

Exceptions to the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods, in connection with building, industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the services therein, in pursuance of statutory powers or duties and for the collection and delivery of postal packets. The usual exceptions for disabled persons' vehicles are also included in the Order.

A copy of the Order together with a map showing the restricted road may be examined during normal office hours at the offices of (i) the County Council, County Hall, Barnsley, (ii) County Engineer, Arundel House, Furnival Gate, Sheffield, and (iii) Sheffield City Council, Branch Library, Four Wells Drive, Hackenthorpe, Sheffield.

If you wish to question the validity of the Order or of any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended as aforesaid, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order you may within 6 weeks from 7th March 1984 apply to the High Court for this purpose.

Dyke Vale Road, both sides, from a point 33 metres north-west of its junction with the north-west kerb-line of *Wickfield Road* for a distance of 70 metres in a south-easterly direction.

Wickfield Road, both sides, from its junction with the south-west kerb-line of *Dyke Vale Road* for a distance of 12 metres in a south-westerly direction. (A.K.) (483)

The South Yorkshire County Council (Stocksbridge, Oughtibridge and Deepcar) (Traffic Regulation) (Consolidation) Order 1980 (Amendment No. 5) Order 1984.

Notice is hereby given that on 7th March 1984 the South Yorkshire County Council made an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the Order which will come into operation on 19th March 1984 will be to prohibit waiting by vehicles at any time in that length of *Birch House Avenue* at *Oughtibridge* which extends from its junction with the south-west kerb-line of *Langsett Road South* for a distance of 15 metres in a south-westerly direction.

Exceptions to the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods, in connection with building, industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the

services therein, in pursuance of statutory powers or duties and for the collection and delivery of postal packets. The usual exceptions for disabled persons' vehicles are also included in the Order.

A copy of the Order together with a map showing the restricted road may be examined during normal office hours at the offices of (i) the County Council, County Hall, Barnsley, (ii) County Engineer, Arundel House, Furnival Gate, Sheffield, and (iii) Sheffield City Council, Library, Church Street, Oughtibridge.

If you wish to question the validity of the Order or of any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended as aforesaid, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order you may within 6 weeks from 7th March 1984 apply to the High Court for this purpose.

WEST YORKSHIRE METROPOLITAN COUNTY COUNCIL
