  - South side, from the centre of the roundabout at the junction of the Link Road with Highweek Street/ Market Street to a point 42 metres east of that centre.
- Courtenay Street :
  - North-west side, from the junction with Bank Street to a point 15 metres north-east of that junction.
- South-east side, from its junction with East Street to a point 30 metres north-east of that junction.
- East Street, both sides, from its junction with Cour-tenay Street to a point 11 metres north of that junction.
- Wolborough Street :
