*The A43 Oxford-Market Deeping Trunk Road (South West Kettering to Weekley) Detrunking Order No. 2 198 .*

The Secretary of State for Transport hereby gives notice that he proposes in relation to the new trunk road to be constructed by him as a bypass to Kettering in the County of Northamptonshire, to make the following Order:

An Order under sections 10 and 12 of the Highways Act 1980 providing that the lengths of the A43 Oxford-Market Deeping Trunk Road situated at Kettering and Weekley in the County of Northamptonshire, known locally as Northampton Road, St. Marys Road, Windmill Avenue and Stamford Road, and described below shall cease to be trunk road as from the date on which notice is given by him to the County Council of Northamptonshire (who will become the highway authority responsible for those lengths) that the trunk roads to be constructed in pursuance of The A43 Oxford-Market Deeping Trunk Road (Kettering Northern Bypass) Order 198 are open for through traffic. The lengths of road to be detrunked are those lengths:

- (i) from a point about 720 metres (788 yards) south-west of the Trunk Road's junction with Westhill Drive, Kettering, generally north-eastwards for a distance of about 1.7 kilometres (1.1 miles) to its junction with Sheep Street, Kettering, and
- (ii) from the Trunk Road's junction with London Road, Kettering, north-eastwards for a distance of about 3.9 kilometres (2.4 miles) to a point about 375 metres (410 yards) north of its junction with Weekley Wood Lane, Weekley.

of Transport, Room P3/073, 2 Marsham Street, London SW1P 3EB; at the Department's Eastern Regional Office, Heron House, 49-51 Goldington Road, Bedford; at the offices of Leicestershire County Council, County Hall, Glenfield, Leicester; Northamptonshire County Council, County Hall, Northampton; Cambridgeshire County Council, Shire Hall, Castle Hill, Cambridge; Harborough District Council, Council Offices, Adam and Eve Street, Market Harborough; Daventry District Council, Council Offices, Church Walk, Daventry; Kettering Borough Council, Municipal Offices, Bowling Green Road, Kettering; East Northamptonshire District Council, Council Offices, Midland Road, Thrapston; and Huntingdon District Council, Pathfinder House, St. Mary's Street, Huntingdon; at the public libraries in Rothwell, Kettering and Thrapston; and at the post offices in Swinford, Naseby, Maidwell, Weekley, Barton Seagrave, Cranford St. John, Spaldwick and Brampton.

Any person may not later than 29th June 1984, or within 3 months from the date of publication of this notice, if such a period shall expire later, object to the making of the above Orders, by notice to the Secretary of State at his address at the Department of Transport, Eastern Regional Office, quoting ref. CE 247/2/26, and stating the grounds of objection. In the preparation of an objection and the statement of grounds of objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.
